Aircraft Delivery and Finance Arrangements

Flexible lease terms with power by the hour (PBH)

- 15 modern Dreamliners on long-term leases
- 13 received; 2 remaining to be delivered in Q422
- 12 year average remaining lease term at low cost with no inflationary adjustments
- PBH lease rates end 12 to 24 months after delivery date to Norse
- 4 aircraft subleased for 18 months to 3rd party, securing fixed cash profit
 - In progressed negotiations to sublease of 5th aircraft, delivery expected Q422

Our advantage is our people

- As of 30 June 2022, the Company employed a total 468 employees
- 323 pilots and cabin crew
- 145 engineers, maintenance personnel and office-based employees.
- The Company has its headquarters in Arendal, Norway and has offices in Oslo Gardermoen, London Gatwick, Fort Lauderdale and Paris.



- Locally based crew in Norway, U.S.,
 UK and France.
- Norse has collective union agreements for all cabin crew in Norway, the UK and the US.
- The company also has collective union agreements with the company's pilots in both Norway and the UK.



Balance sheet at 30 June 2022

- Total liquidity \$106 million
- Current assets \$133 million
- Current liabilities \$52 million
- Aircraft lease liabilities \$908 million
 - 11 of 15 aircraft delivered at 30 June 2022
 - Average remaining lease length 12 years
- Balance sheet does not include the positive impact of the 4 aircraft subleased to a 3rd party for 18 months from around 30 June 2022
 - Approximately \$40 million



Cash flow H1 2022



- Total liquidity \$106 million:
 - \$76 million free cash
 - \$5m restricted cash
 - \$24m investment in VTIP (US Treasury Inflation-Protected Securities)

Outlook

- Challenging winter season ahead
 - High global inflation, high aviation fuel price and uncertain traveler behaviour post-Covid
- Norse will take a careful approach to adding new routes during Winter 2022 and will potentially thin its winter program in line with demand
 - Advantage of PBH flexible lease terms
 - Lean organization
- Norse will be perfectly positioned to take advantage of an expected strong Summer 2023 season
